### Liability Release Agreement – Release of All Claims

Furthermore, I hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein. The undersigned further hereby agree to hold harmless and indemnify ECTC, its coordinators, co-workers, employees, and agents, for any liability sustained by said organization as a result of the negligent, willful or intentional acts of said participant and/or his or her child participant, including expenses incurred attendant thereto.
